

In case contractual interest of a term loan reaches its maturity date, it will be considered as a daily payable asset.

Usually daily payables are equalised against a settlement account through a client payment.

In case the payment related to interest does not cover the entire amount of the daily payable interest, the remaining amount is shown in the measure Daily Payable Interest.
